



Matt is Chicago native and graduate of Northwestern University who currently works as market researcher. Fortunately, he works right down the street from HighSight and is able to mentor our students several times a week. Matt has been tutoring and mentoring since high school, where he started working in the library as an editor of his peers' essays and college applications. He continued to mentor through college and into adulthood, previously working with a family of African refugees before linking up with HighSight. To date, Matt has worked almost exclusively with the junior class, starting out with them as freshman. If you asked him, he would characterize his experience with them as challenging, fun, and incredibly rewarding. Despite his dislike for the class's taste in music, you can tell he absolutely loves the HighSight scholars and is personally invested in their academic success. In addition to his efforts as a mentor, Matt has also been active in fundraising events using his marketing skills to help raise money for the organization.

For the 14th year in a row, 100% of our graduated seniors were accepted into college.

The 16 alums in our 2013 graduated class were awarded nearly \$2,240,000 in scholarships and grants for their collective four years of college, an average of more than \$140,000 per student

Outside of my host family, I had classes of Mandarin, Chinese calligraphy/music, Tai Chi, and physical education. Overall, the experience I had in China opened my eyes to a whole new world. I would have never dreamed it possible for me to have such an amazing experience before college.
